## Eigenauer's Persian Sales Contract

The \_\_\_\_\_ (Kitten or Cat) is being sold as a \_\_\_\_\_ (Pet or Breeder) for the purchase price of \$\_\_\_\_\_. The purchase price does not include shipping. Pet kittens must be spayed or neutered (altered) by 6 months of age, if not already done so by breeder.

**If the kitten was not altered by the breeder:** In order to receive CFA papers, Pedigree's, and spay \$175.00 or neuter \$150.00 refund, the buyer must send a copy of the spay or neuter printed receipt with the name, address, and phone number of the veterinarian that altered the kitten. The receipt must be received by the time the kitten is 7 months of age. The receipt must also include the kitten's date of birth and the name of the Sire and Dam. If I do not receive your receipt, I have the option of taking legal action against you.

**Deposit-Payment-Shipping:** Kittens are reserved on a "first come-first serve" basis in the order that deposits are received. If a deposit is placed on a future litter, once the litter arrives, the buyer has until the kitten is 4 weeks old to pick their kitten. If buyer has not yet chosen their kitten by 4 weeks of age, the seller will pick a kitten for the buyer. Kittens will become available around 12 to 14 weeks of age, although some may take a little longer. Our Persians will go to your home with CFA Papers and Pedigree's (if kitten was already altered), a written genetic health guarantee, and parent's PKD Results. Kittens will be healthy, socialized, eating, drinking, litter trained, vet checked, de-wormed, and vaccinated (age appropriate). You will also receive kitten care information, food, and toys.

**NON-REFUNDABLE deposit** for a kitten is \$300.00. The deposit will hold the kitten of your choice until it is ready to leave us. We are unable to hold kittens without a deposit.

**Please note:** Placing a deposit on a kitten states that you have read and that you agree with all terms of our contract even if the contract has not yet been signed. No kitten will leave our premises without a signed contract.

If said kitten is to be shipped, full payment must be made 14 days prior to shipping said kitten, providing that payment clears before said kitten is ready to leave our home. If kitten is being picked up from the seller and has not been paid for in full, the remaining balance MUST be made in CASH on the pickup date.

Buyer has until the kitten is 14 weeks of age to pick up (if ready) or arrange shipping of said kitten. If said kitten is not picked up (if ready) or shipping arrangements have not been made within the 14 weeks, ALL money deposited or paid by buyer is considered forfeited and said kitten may be sold to another interested family. If said kitten needs to stay longer, there will be a \$5.00 fee per day, for upkeep.

We accept cash, personal check, and \*PayPal (which uses your bank account, debit card, or credit card) as forms of payment. \*With every PayPal transaction there will be a 3.5% service fee added to the amount paid.

We prefer to have families pick up their kittens at our home, but we realize that this is not always possible. If you need your kitten shipped, we will ship domestic only, no international shipping. Shipping Cost is \$450.00 East Of Wisconsin and \$500 West Of Wisconsin. All Airlines have stopped shipping unaccompanied snub nose cats and dogs; therefore, I contract with someone who I meet in Chicago and hand deliver your kitten to. She will fly to your Airport and you need to meet her at your airport. She gets very busy at times, so Please bear with us. Sometimes we cannot get your kitten to you the exact day you would like. You are also welcome to fly into MKE Milwaukee WI airport and pick your kitten up, I will meet you there.

**Health Guarantee & Return Policy:** In the unlikely event this kitten or cat develops a fatal disease resulting from a genetic defect in the first year after purchase, the kitten or cat will be replaced with a similar cat or kitten of equal quality. To receive a replacement of kitten, (replacement kitten will be provided as soon as one is available) the buyer must have a licensed qualified veterinarian diagnose said kitten as to what caused the death. Buyer pays for the exam and the shipping costs. Seller must receive a copy of the original exam report by the vet, within the 1-year guarantee timeframe. See below on how to validate the Health Guarantee with a veterinarian exam within 48 hours of receipt of kitten or cat.

**Veterinarian exam within 48 hours of buyer's receipt of kitten or cat to validate Health Guarantee:** Buyer understands and agrees that in order to validate the Health Guarantee, buyer MUST isolate the kitten from any other animals in the buyer's home until a qualified licensed veterinarian performs a health check. It is the buyer's choice to have a health check performed within 48 hours of buyer's receipt of said kitten (two business days, not including weekends or holidays) by a qualified licensed veterinarian and buyer is urged to do so. Failure to have the kitten examined by a qualified licensed veterinarian within the above reference 48 hours of said kitten, will make the Health Guarantee in this Sales Contract NULL and VOID. After the above referenced 48 hours have elapsed without a qualified licensed veterinarian health check, buyer assumes all responsibility and ownership of said kitten.

If during the 48 hours, referenced above, a qualified licensed veterinarian finds a serious illness or genetic deformity in said kitten, **the kitten or cat may be returned for a replacement.** Serious illness means a shortened life span or a painful life span. The buyer must provide the written examination report from the licensed qualified veterinarian, stating the problem identified with said kitten or cat. The written statement must include the name, address, and phone number of the veterinarian that examined the kitten or cat along with the kitten's or cat's date of birth and name of Sire and Dam. The seller will not provide a replacement if apparent neglect or improper care has been given to the kitten or cat. A replacement kitten or cat will only be given when the seller has one available. The seller does not give a Cash Refund on any returned kitten or cat. The seller cannot guarantee that the replacement kitten or cat will look exactly the same as the returned kitten or cat. If buyer accepts a replacement kitten or cat, the buyer is solely responsible for all shipping and delivery costs. Seller reserves the right to refuse sale, payment terms, and to nullify contracts at our discretion any time prior to shipping or pickup date.

After said kitten leaves the seller's premises, seller assumes no responsibility for vaccinations, vet visits, tests, veterinarian expenses due to injury, landlord's disapproval, allergy to animal, disagreement of family member, or for any other reason.

It is agreed that this sale is taking place in the State of Wisconsin, USA, and it is agreed that this contract will be interpreted pursuant to the laws of the State of Wisconsin USA. Therefore, any legal issues are to be handled in the court system of Racine County, WI, USA.
